MEMBER PRICING

Up to 25 people:	\$250 (\$62 deposit)
26 to 50 people:	\$350 (\$87 deposit)
51 to 75 people:	\$500 (\$125 deposit)
75 to 200 people:	\$650 (\$162 deposit)

NON MEMBER & CORP PRICING

Up to 25 people:	\$300 (\$75 deposit)
26 to 50 people:	\$450 (\$100 deposit)
51 to 75 people:	\$600 (\$137 deposit)
75 to 200 people:	\$750 (\$175 deposit)

Renter must provide a deposit of 25% of total rental fee when the reservation is made.

Renter MUST also provide a credit card number for any damages that may occur to Club property. Full payment and paperwork are due one week prior to rental reservation date.

A cancellation notification needs to be provided 72 hours prior to event date or your deposit will be held.

*Rental rates reflect a 3-hr time block. An additional hour may be purchased – ask for details. Lifeguards included in these rates.

RENTAL AGREEMENT & WAIVER

Renter must provide a deposit of 25% of total rental fee when the reservation is made. Renter MUST also provide a credit card number for any damages that may occur to Club property. A cancellation notification needs to be provided 72 hours prior to event date or your deposit will be held.

Use of facility to include, tennis courts (when not in use by members), volleyball, ping-pong, outdoor swimming pool(s), restrooms, children under 10 play yard, barbeques, picnic tables.

Tennis court rules: Courts may be used for tennis only. Proper tennis attire must be worn – shirts required, only tennis shoes with non marking soles on courts, no bare feet. No furniture on courts. No food or drinks except plastic water bottles on courts.

Club facilities are **always open to members** except for the reserved barbeque areas.

All members and guests must be out by the end of their scheduled rental time.

Parties are scheduled during designated times in 3-4 hour intervals (12:30-3:30pm OR 5:00-8:00pm). Rental times include clean up. Renters are allowed to setup 30 minutes prior to their scheduled party times.

Limit to 200 people.

Private parties only. No fundraisers.

No smoking/vaping on premises.

No loud music. No live bands.

No glass bottles or containers.

No pets/animals.

If rental is for 200 people, renter must provide a Certificate of Liability Insurance claiming Yuba City Racquet & Health Club as the additional insured (\$1,000,000.00). Such insurance can be obtained through a home owner's policy.

Non Members and Corporate renters must provide a valid photo ID before reserving a date.

Renters must clean up after themselves, leaving the facility in great shape for the next group.

Renters are responsible for the behavior and well being of all their guests, both members and non-members. Renters are also responsible For any property damage.

Rental dates / times are officially reserved only when YCRC receives a completed rental agreement, a 25% deposit fee is paid (based on the total amount of the rental price) and a credit card # provided. The facility must be left in the same condition as it was rented. In the event damages are incurred by members of your party during your event, the amount will be billed to the renters credit card.

One lifeguard per 25 people – subject to change based on age-range of guests. **Lifeguard fees are included in your set party rental rates** at the amount of \$30.00 per hour per guard. YCRC will arrange for lifeguards.

Full payment and paperwork are due one week prior to rental reservation date. If YCRC does not receive a cancellation within 72 hours of the scheduled party's date your deposit will be held. In the event of situations out of our control, such as weather, equipment, etc., YCRC serves the right to reschedule your event upon availability.

YCRC reserves the right to refuse service to anyone.
